GMW 2021 WAS HOSTED ONLINE, WITH GMW FACULTY ARTISTS STREAMING LIVE FROM CAMPUS AT NEW ENGLAND CONSERVATORY IN BOSTON, MA. AN AUDIO-VISUAL PERFORMANCE CONCEIVED BY SYRIAN COMPOSER AND CLARINETIST KINAN AZMEH AND SYRIAN ARMENIAN VISUAL ARTIST KEVORK MOURAD, THE RESULT IS AN IMPRESSIONISTIC REFLECTION ON THE UNITY OF LOSS, LONGING, AND THE IMPACT OF TRAGEDY ON OUR SENSE OF 'HOME.' RATHER THAN FOLLOW A NARRATIVE, THE ARTISTS DOCUMENT 'HOME' WITHIN SPECIFIC MOMENTS IN SYRIA'S RECENT HISTORY, USING THE COUNTERPOINT BETWEEN IMAGE AND SOUND TO ESTABLISH A SENSE OF SUSTAINED URGENCY AND CONTINUED HOPE FOR BOTH THEIR HOMETLAND AND COMMUNITIES AROUND THE WORLD.
